



Lady McAdden 500 Club Rules

The name of the club shall be “Supporters of Lady McAdden 500 club” (hereinafter called the “500 Club”). The authorised promoter of this lottery is Lady McAdden Breast Screening Trust (Hereinafter called Lady McAdden). Sale of tickets is confined to a maximum of 500.

The object of the 500 club shall be to raise funds to support the Lady McAdden services for all women of Essex and beyond.

The club is open to **ALL** except staff members of the Lady McAdden.

Any person subscribing to the 500 Club shall become a member of the 500 Club (a member) and will remain so for a minimum term of one year (subject to receipt of funds).

All members of the 500 club must be aged 18 or over and may take more than one subscription which will count as an additional member of the 500 club. Each ticket will be allocated a membership number and entered into 12 monthly draws. The draw will be made by an Independent person and witnessed to that effect each month and recorded for audit purposes.

Details of the winners each month will be detailed on Lady McAdden social media.

All winners will be informed and paid by bank transfer where possible (cheque in exceptional circumstances). All payments will go into an account with the member’s name on it. The member holds the right to donate the funds back to Lady McAdden if they so wish (plus gift aid if eligible)

The price of each annual ticket will be £60.00 (payments may be spread into easy payments of £15 per quarter or £5pm) payable to Lady McAdden Breast Screening Trust in advance.

45% of the proceeds of the lottery shall be devoted to the provision of prizes. The whole of the remainder of the proceeds shall be devoted to the purpose of the Lady McAdden. (The above figures are calculated on the assumption that exactly 500 tickets have been sold).

If the promoter sells less than 500 tickets, will reduce the value (but not the number) of the prizes, but the total value of prizes shall not be less than 45% of the proceeds.

The prize pot will be doubled in October to celebrate Breast Cancer Awareness Month (previously Christmas)

Administration of the 500 Club is controlled by the Management Team of Lady McAdden. The Rules of the 500 Club may be amended by the Management Team of Lady McAdden at their discretion and decisions by the Management Team shall be final and binding on all matters relating to the operation of the 500 club

500 Club accounts shall be kept by and be audited annually with the Trust’s formal accounts. In joining the 500 club all Members agree to abide by these rules
